# OTSEGO REFUGEE RESETTLEMENT COALITION FUND OPENS

The Community Foundation of Otsego County is pleased to announce the creation of a new fund, the Otsego Refugee Resettlement Coalition Fund.

Founded in October 2021 by a dedicated group of volunteers, the Otsego Refugee Resettlement Coalition began to look at legal ways to bring refugees to Oneonta. With over 100 representatives from area nonprofit organizations, businesses, educational institutions, as well as local individuals and members of the faith community, the Coalition successfully brought two refugees to Oneonta this past summer. The Coalition's work was susequently featured in the *Wall Street Journal*.

With the Otsego Refugee Resettlement Coalition Fund in place, the Coalition is getting ready to apply for more legal refugees. "The Community Foundation has been thrilled to work with, and within, the Coalition and the results have been quite impressive," said CFOC Executive Director Jeff Katz. "With the creation of the Otsego Refugee Resettlement Coalition Fund, we can work more effectively to raise funds and bring more people to Otsego County."

#### ANNOUNCING THE **OTSEGO LAKE FUND**



Three Otsego Lake organizations have joined with the Community Foundation of Otsego County to create a fund to support the long-term health of Otsego Lake and watershed.

The Otsego Lake Watershed Sustainability Fund will be advised by the leaders of three organizations: the Otsego Lake **Association, the Watershed Supervisory** Committee (Village of Cooperstown, Towns of Otsego, Middlefield and Springfield), and SUNY- Oneonta's Biological Field Station. The fund will be managed by the CFOC.

According to Jim Howarth, co-president of the Otsego Lake Association, "With the visible arrival of HABs (harmful algae blooms) in 2022, we found we needed more resources to address our concerns for the lake. We faced such crises before (zebra mussels and quagga clams to name two) and lacked a fund to meet our needs."

He shared this concern with Jeff Katz, Executive Director of the Community Foundation, who suggested creating a long-term fund to provide these missing resources. The resulting Otsego Lake Watershed Sustainability Fund is dedicated to the long-term health of the lake and its watershed including its environmental, recreational, and aesthetic attributes.

Florian Reyda, Director of the SUNY-Oneonta Biological Field Station, said, "The fund will provide important support for future work and provide an excellent opportunity for a united effort among local organizations to work together to ensure the health of Otsego Lake."

Bertine McKenna, chair of the Watershed Supervisory Committee, agreed the fund will encourage more coordination among organizations interested in the lake. She said, "This fund can help us support necessary actions to protect our lake and watershed. Our goal is to take every step possible to protect this beautiful natural resource. The fund can also provide seed money to help local organizations apply for important grants. We thank the Community Foundation for leading us down this path."
